All visits must be carried out with adherence to Ministry of Health (MOH) SOPs as per APPENDIX (Annex 25 & 26 of MOH. Guidelines on COVID-19). Choice of EP during this period will be from the vicinity of the IHL to avoid traveling by air plane. Mileage claim has to be entertained for the safety of the EP. Meeting rooms must be large enough to cater for social distancing. Interview session has to be made in numerous batches of MAX 3 persons/group. PPE and hand washing/sanitizing facilities must be provided throughout the visit to all.
